2.		Please, clearly clarify whether any of the projects include, in any form, the execution/supply / implementation of construction works.	Please, refer to the answer to Question 1.
3.		If construction is not included, please confirm in writing that the contract is limited to design documentation and tender materials only.	Please, refer to the answer to Question 1.
